## PART 1:

### PRELIMINARY PROVISIONS

#### 1. Citation:

These regulations may be cited as the Telecommunications Numbering Regulations, 005/001/2021.

#### 2. Interpretation:

In these regulations unless the context otherwise requires.

- 1) **“Act”** means the Postal and Telecommunications No. 50/2020.
- 2) **“Assignee”** means any electronic communication operator or entity assigned Electronic Communication Numbers by the Ministry.
- 3) **“Electronic Communication”** means radio communication or, as appropriate, the communication of information in the form of electronic speech or other sound, data, text or images, by means of guided and unguided electromagnetic energy.
- 4) **“Electronic Communication Operator”** means any person licensed by the Ministry to provide

#### EREY BIXIN

Xeer-nidaamiyahan dhexdiisa erayadan soo socda waxa loola jeedaa:

- 1) **Adeeg Isgaadhsiineed:** Waxa loo la jeedaa adeeg kasta oo loo fidiyo macaamiisha iyada oo la adeegsanayo shebekadaha isgaadhsiinta.
- 2) **Adeegyada Dheeraadka Ah (Value Added Service):** Waxa loo la jeedaa adeeg kasta oo ay bixiyaan ruqsadleyaashu marka laga reebo wicitaanada iyo internet-ka.
- 3) **Isgaadhsiin:** Waxa loola jeedaa, lalin, diris, ama helis calaamad, biliig, xog, qoraal, maqal iyo muuqaal ah oo dhex mara shebekadaha.
- 4) **Lambar:** Waxa loola jeeda astaan tiro oo loo adeegsado adeeg isgaadhsiineed.

- 5) radio communication or telecommunication services.
- 6) **“Electronic Communication Number”** means a number, sign or any other mark which an electronic communication operator in its delivery of electronic communication services uses for identification of electronic communication facilities in order to connect between the place of transmission and the place of reception, or for identification of the type of content of transmission the electronic communication facility is to deliver.
- 7) **“Ministry”** means the Ministry of ICT.
- 8) **“National Numbering Plan”** means the scheme of identification prescribed in these Regulations or other regulations made and maintained by the Ministry for ensuring that electronic communications are correctly and efficiently directed to their intended points of reception.
- 9) **“Short Code”** means a number that is not a supplementary code and has a maximum of six (6) digits.
- 10) **“Unstructured Supplementary Service Data”** or in its acronym USSD means a Global System for Mobile (GSM) communication technology

- 5) **Lambar gaaban:** Waxa loola jeedaa astaan tiro oo ka kooban saddex ama afar lambar oo loo adeegsado adeeg isgaadhsiineed.
- 6) **Lambar USSD:** Waxa loola jeedaa astaan tiro oo ka kooban saddex lambar kuna bilaabanta calaamadda (\*) kuna dhammaata (#) oo loo adeegsado adeeg isgaadhsiineed.
- 7) **Lambar adeeg dheeraad ah:** Waxa loolaa jeedaa astaan tiro oo loo adeegsado adeegyo dheeraad ah.
- 8) **Marin “Gateway”:** Waxaa loo la jeedaa marinka is-waydaarsiga xogta isgaadhsiinta la diro am la helo iyada oo lala soconayo dhaqaaqaayada isgaadhsiinta.
- 9) **Qoondayn:** Waxa loola jeedaa astayn lambarro u gaar ah ruqsadle si uu u bixiyo adeeg isgaadhsiineed.
- 10) **Ruqsadle:** Waxa loo la jeeda shirkad la siiyay ogolaansho ay ku bixin karto adeeg isgaadhsiineed si waafaqsan Xeerka Boosaha iyo Isgaadhsiinta Somaliland Xeer Lr.50/2020.
- 11) **SIM (Subscriber Identity Module):** Waxa loola jeedaa kaadh loo adeegsado aaladaha isgaadhsiinta si loogu aqoonsado macmiilka.
- 12) **Shebakad Isgaadhsiin:** Waxa loo la jeedaa habka loo gudbiyo ama la isku waydaarsado xogaha isgaadhsiinta ee kala duwan.

- 11) that is used to send text between a mobile phone (using a number that contains at least one
- 12) occurrence of a star (\*) or a hash (#) and an application program in the network.
- 13) “Utilized Numbers” means numbers that are allocated to customers or kept for internal system and human communications or that have been distributed to a dealer on SIM cards.
- 14) “VAS Short Code” means an electronic Communications number designed for Value Added Services.
- 15) “Value Added Services” means extra electronic communication services as provided by an assignee other than basic telecommunication services.

### 3. Application:

These regulations shall apply to all electronic communication operators and any service providers in relation to telecommunication numbering resources.

### 4. Objectives:

- 1) To promote growth and development of the communication sector in Somaliland.
- 2)

### XADKA DABBAQAADDA XEER-NIDAAMIYAHA

Xeer-nidaamiyahan waxa lagu fulinayaa cidda ama ruqsadle adeegsada lambarrada wicitaanada ama farriimaha ee isgaadhsiinta iyada oo la tixraacayo Xeerka Boosaha iyo Isgaadhsiinta Somaliland Xeer Lr. 50/2020.

## Qodobka 4aad

### UJEEDOOYINKA XEER-NIDAAMIYAHAN

Ujeedooyinka xeer-nidaamiyahan waxa ka mid ah:

- 1) Kobcinta iyo kor u qaadidda adeegyada isgaadhsiinta ee ay bulshadu hesho.



- 3) Numbers are understood to be national resources that are not owned by customers or licensees.
- 4) To promote efficient utilization of the number resources in Somaliland.
- 5) To establish framework for the administration of the numbering resource to ensure transparency and efficient management.
- 6) Numbers can be assigned efficiently, quickly, transparently and fairly, without undue discrimination against particular customer classes, licensee types and communication technologies.

## **PART II:**

### MINISTRY ROLES

#### **5. Power of the Ministry:**

- 1) Assignment of telecommunications numbers for operators and business purposes.
- 2) The ministry shall manage and monitor all electronic communications numbers in order to ensure fair and efficient usage.
- 3) The ministry shall take enforcement measures against misuse or illegal use of the electronic numbering resources.

- 3) Kor u qaadidda habsami u adeegsiga lambarada isgaadhsiinta dalka.

- 5) Lambarrada waxa loo qoondaynayaa si hufan, dhakhso leh, daahfuran, oo loo siman yahay, iyada oo aan cidnaba si gaar ah loo takoorayn.

- 4) The Ministry shall maintain and publish the National Numbering Plan up-to-date versions of the Allocation status and usage conditions.

**6. National Numbering Plan Management:**

- 1) National numbering plan shall include electronic communication numbers used to identify:
- a) Electronic communication networks or various carriers.
  - b) Terminal facilities for cellular phones.
  - c) Signaling transmission equipment.
  - d) Emergency, help, health, and inquiry calls.
  - e) Terminal transmission line facilities for data communication services.
  - f) Unstructured Supplementary Service Data (USSD) applications.
  - g) Value added services.
  - h) Government, security and firefighting numbers.
  - i) Short codes for business purposes.
- 2) The Ministry shall maintain and update the National Numbering Plan as appropriate.

### SHAQADA IYO WAAJIBAADKA WASAARADDA

### **Qodobka 5aad**

#### AWOODDA WASAARADDA:

Shaqada Wasaaraddu waa:

- 1) Astaynta lambarada adeegyada isgaadhsiinta ee ruqsadleyaasha iyo shirkadaha ganacsiga.
- 2) Maamulidda iyo kormeeridda dhamaan lambarada isgaadhsiinta si loo hubiyo isticmaal ku dhisan cadaalad iyo hufnaan.
- 3) Dhaqangelinta iyo in ay tallaabo ka qaaddo adeegsiga sharci darro ee lambarada isgaadhsiinta.
- 4) Ilaalinta iyo soo saaridda jadwalka adeegsiga lambarada isgaadhsiinta si joogto ah.

### **PART III:** **NUMBERS**

#### **7. Procedure for Assignment of Electronic Communications Numbers:**

- 1) An electronic communication number shall be issued to:
  - a) Licensed telecommunication network services licensee.
  - b) Unlicensed entity for VAS short codes subject to the nature of Value-Added Services to be provided.
- 2) Any electronic communications licensee or unlicensed entity requiring electronic communication numbers shall submit to the Ministry:
  - a) The appropriate application forms.
  - b) All relevant documents and reasons for use of the said numbers.
  - c) Estimated demand as the grounds for said request.
  - d) Plans for provision of telecommunications service for the numbers required.
- 3) Subject to sub regulation (2), the Ministry may assign electronic numbers and issue a certificate

### **Qodobka 6<sup>aad</sup>**

#### **MAAMULKA QORSHAYNTA LAMBARADA ISGAADHSIINTA**

- 1) Qorshaynta lambarrada isgaadhsiintu waxa ay ka koobnaan doonaan lambarro loogu talo galay qaybahan hoos ku xusan:
  - a) Shebekadaha isgaadhsiinta iyo shirkadaha xidhiidhiya wicitaanada dibedda ee kala duwan.
  - b) Lambarrada shabakadaha wicitaanada gudaha.
  - c) Lambarrada qalabka wicitaan gudbiyaha dibedda (carrier) ee ruqsaleyaasha.
  - d) Lambarrada xaaladaha degdegga, gurmada, gargaarka, wicitaanada macluumaadka iyo caafimaadka.
  - e) lambarrada adeegyada isgaadhsiinta xogta (data) ee qalabka lalinta.
  - f) Lambarrada USSD-ga ah ee shirkadaha isgaadhsiintu adeegsadaan.
  - g) Lambarrada adeegyada dheeraadka ah (VAS) ee shirkadaha isgaadhsiinta.

of assignment subject to payment of prescribed fees and other conditions set by the Ministry.

- 4) The Ministry shall identify Gold, Silver, Bronze and Ordinary VAS short codes according to digit patterns for the most memorable to the least memorable codes.
- 5) The Ministry shall determine an application for numbering resources within **20 days** from the date of receiving the application.

#### **8. Tariffs & Auditing of Electronic Communication Numbers:**

- 1) An assignee shall submit in writing to the Ministry on any day in the month of January of each year, the utilized electronic communication subscriber numbers for the purposes of auditing and billing.
- 2) An assignee should pay the yearly numbering fees.
- 3) Where the assignee does not inform the Ministry on the utilization of the electronic communication numbers or pay relevant fees such electronic communication numbers shall be removed from the numbering register and when needed, the corresponding assignee shall re-apply for it again depending on the availability.

- 2) Wasaaraddu waxa ay ilaalinaysaa isla markaana cusboonaysiinaysaa qorshaha lambarrada isgaadhsiinta.

**9. Assignee Obligations:**

- 1) Any assignee shall use the electronic communication numbers as assigned by the Ministry in accordance with the national numbering plan and shall ensure that the resources are:
  - a) Utilized efficiently.
  - b) Limited to provision of electronic communication services.
  - c) Utilized in a manner that electronic communication facilities or services may be identified.
  - d) Paid for in accordance with the Application Guidelines and Fees for Numbering Resources as may be provided by the Ministry.
- 2) All telecommunications operators shall assign same numbers to the services listed below:
  - a) Emergency.
  - b) Health facilities.
  - c) Security.
  - d) Firefighting.
- 3) The annual numbering fee payable to the Ministry on assigned subscriber numbers.
- 4) An assignee shall not re-sell or trade any part of the assigned electronic communication numbers to a third party.

**CUTUBKA 3AAD****LAMBARRADA ISGAADHSIINTA****Qodobka 7aad****NIDAAMKA ASTAYNTA LAMBARRADA ISGAADHSIINTA**

Marka la astaynayo lambar isgaadhsiineed waxa loo codsanayaa sidan soo socota:

- 1) Codsiga astaynta lambar isgaadhsiineed waxa loo oggol yahay:
  - a) Ruqsadle ka shaqaysiiya shebekad isgaadhsiineed.
  - b) Shirkad u adeegsanaysa adeegyo dheeraad ah oo ganacsi.
- 2) Shirkadda ama ruqsadlaha codsanaya Lambarro waa in uu buuxiyaa shuuradahan, soona gudbiyaa lifaaqyada hoos ku xusan:
  - a) Cosdi ku socda Wasaaradda
  - b) Formka codsiga lambarrada.
  - c) Nuqul Ruqsaddiisa ah (Isgaadhsiin/ Ganacsi).
  - d) Warqadda Cashuur La'aanta.

- 5) An assignee shall be responsible for discontinuation of traffic related to a numbering resource whose service has ended.
- 6) Where the assignee does not intend to maintain the assigned number, he shall notify the Ministry in writing **ninety days** before the expiration of the current numbering certificate.

#### **10. Changes of electronic communication numbering:**

In replanning circumstances, the Ministry shall issue notice to the public and the assignees at least **six (6) months** prior to the date of the change.

#### **11. Cancellation of electronic communication numbers:**

- 1) The Ministry may cancel the assignment of a numbering resources where the assignee:
  - a) Fails to use an electronic communication number assigned by the Ministry.
  - b) Fails to pay annual fees.

e) Caddaymaha Sababaha Adeegsiga Lambarrada iyo Qorshahiisa.

- 3) Wasaaraddu waxa ay siinaysaa Ruqsadlaha ama shirkadda Shahaadad lagu caddaynayo lambarrada isgaadhsiinta ee loo asteeyey kaddib marka la oggolaado codsigiisa.
- 4) Ruqsadluhu/Shirkaddu marka loo asteeyo lambarrada isgaadhsiinta waxa uu bixin doonaa tacriifadda lambarrada isgaadhsiinta ee ku xusan shaxda tacriifadda ee Wasaaradda.
- 5) Shahaadada waxa lagu caddaynayaa lambarrada la asteeyay iyo wakhtiga adeegsiga.
- 6) Wasaaraddu waxa ay tilmaamaysaa heerka ruqsadda lambarrada gaagaabaan ee adeegyada dheeraadka ah.
- 7) Muddo **labaatan maalmood** gudahood ah ayay wasaaraddu kaga jawaabaysaa oggolaanshaha ama diidmada codsiga shirkadda ama ruqsadlaha.

## PART IV

### GENERAL PROVISIONS

#### 12. Compliance, Offences and Penalty

- 1) A person shall not use an electronic communication number without a certificate of assignment issued by the Ministry.
- 2) Any electronic communications licensee shall not use any short code either on direct dialing, SMS, or Unstructured Supplementary Service Data (USSD) without an authorization by the Ministry.
- 3) Mobile network operators shall not integrate any numbering resource or continue connecting where the assignee has not presented the renewed certificate on yearly basis.
- 4) A person shall not re-sell or trade any kind of electronic communication numbers.
- 5) Where the assignee surrenders the number, and then found to be active in the network it will be regarded as misusing that number by that Mobile Network Operator.
- 6) A person who contravenes or fails to comply with the provisions of these regulations commits an offence and on conviction shall be liable to the fines in the appendix.

- 3) Haddii shirkad ama ruqsadle bixin waayo tacriifadda sannadlaha ah, ama uu adeegsan waayo lambarrada loo asteeyay, isla markaana la wadaagi waayo wasaaradda adeegsigiisa lambarrada, wasaaraddu dib ayay ula noqonaysaa, waxaana waajib ku noqonaysa inuu dib u soo codsado taasi oo ku xidhan helitaanka lambarradaas.

**13. Amendments:**

This regulation will be amended according to the Ministry when needed.

**16. Enforcement:**

This regulation will be enforced by the Ministry when signed by the Minister and published in the official gazette.
